03.07.2021 04.07.2021	Saturday Sunday	Day-2 to Day-3	The President / Secretary General of RSFI shall prepare the list of authorized representatives of the Member State/Union Territory in <b>Form-1</b> and circulate a copy of the list so prepared to all members State/Union Territory on 04.07.2021 by display, on the website.
05.07.2021 to 10.07.2021	Monday to Saturday	Day-4 to Day-9	Nomination of a candidate for election of Office Bearer/Members of RSFI in <b>Form-2 by email by 5 PM (10/07/2021)</b>
11.07.2021	Sunday	Day-10	the Returning Officer shall prepare a list of all nominations received by him, email wise, post wise, in <b>Form-3</b> , and publish the same in a conspicuous place in the office of Returning Officer.
12.07.2021	Monday	Day-11	The Returning Officer shall scrutinize each nomination paper, one by one and determine its validity or otherwise. Each candidate or one of his/her authorized representative shall have the right to be present and raise objection in relation to nomination of a candidate for the post for which he/she has filed his/her nomination. After scrutiny of all nomination papers, the Returning Officer shall prepare a list of validly nominated candidate in <b>Form-4</b> . The contesting candidate can take a copy from the Returning Officer.
