08.05.2025	Thursday	Day-1	Received name(s) of representatives from each Permanent Member State/Union Territory, who can vote on their behalf.
09.05.2025 11.05.2025	Friday Sunday	Day-2 to Day-4	The President / Secretary General of RSFI shall prepare the list of authorized representatives of the Member State/Union Territory in Form-1 and circulate a copy of the list so prepared to all members State/Union Territory on 11.05.2025 by display, on the website.
11.05.2025 to 16.05.2025	Sunday to Friday	Day-4 to Day-9	Nomination of a candidate for election of Office Bearer/Members of RSFI in Form-2 by email by 5 PM (16/05/2025)
17.05.2025	Saturday	Day-10	the Returning Officer shall prepare a list of all nominations received by him, email wise, post wise, in Form-3 , and publish the same in a conspicuous place in the office of Returning Officer.
18.05.2025	Sunday	Day-11	The Returning Officer shall scrutinize each nomination paper, one by one and determine its validity or otherwise. Each candidate or one of his/her authorized representative shall have the right to be present and raise objection in relation to nomination of a candidate for the post for which he/she has filed his/her nomination. After scrutiny of all nomination papers, the Returning Officer shall prepare a list of validly nominated candidate in Form-4 . The contesting candidate can take a copy from the Returning Officer.
19.05.2025 20.05.2025	Monday and Tuesday	Day-12 Day-13	Each candidate whose nomination has been found valid on scrutiny shall be entitled to withdraw his/her candidature from 19.05.2025 9.00 AM to 20.05.2025 5.00 PM. The notice of withdrawal shall be submitted in Form-5 , either by the candidate in person or by his email ID.
21.05.2025	Wednesday	Day-14	The Returning Officer shall prepare the final list of contesting candidates in Form-6 , and display a copy of the said list in conspicuous place in his office and on Federation's website. A copy of the list shall be provided to each candidate/their authorized representatives, if they so demand.
