Subject: Important Update Regarding Official Communication ,Integral & Cohesive approach , and also the Functionality of the Federation .

Dear All,

I wish to bring an important matter to your attention.

We cannot allow any individual to undermine the functioning of our federation, as has been persistently done by Mr. Bhagirath for the last several months. His sole focus and aim appears to prove his points that everyone else except himself & APRSA (Andhra Pradesh Roller Skating Association) is entirely in the fallacious & wrong. It is noteworthy that he dubs — be it all the State Associations, all the office bearers of RSFI, the entire Executive Committee members, or the officials of all state bodies are being put in the red zone and he is the only righteous person around.

He is dismissive of our federation's legacy and achievements built over many years assiduously from the position of non-existent system, procedure and the institutional functioning which he is out to dislodge that just cannot be allowed to be done by anyone howsoever great he or she may be or placed in the hierarchical set up of RSFI. Bet it our online entry systems, online submission processes, official email IDs, and a proper, systematic channel for providing timely information. Placing himself above all established systems, he is engaged purely and solely in validating his own arbitrary statements as the supreme authority, all we know which he is not.

Moreover, Mr. Bhagirath Dadhich's attempt to acknowledge unrecognized or parallel associations in certain states is a deliberate attempt to destabilize the RSFI by wrongfully trying to muster support in his favour, which is absolutely illegal and unpalatable. Such attempts will not be tolerated under any circumstances. The RSFI is an institution built through the collective efforts of the skating fraternity and is not the personal property or fiefdom of any individual. The General Secretary is relentlessly working day in & out to Whittle down anything and everything.

In the aftermath of the 2025 RSFI elections, only one Executive Committee meeting had been held, other than that No General or Emergency Meeting has been convened. Furthermore, in the 2nd July

2025 Executive Committee meeting, there was no agenda item related to the disaffiliation of any existing unit or the grant recognition to any new unit, therefore issuance of letter by Mr. Bhagirath Kumar is to create fissure / discord all around which he will not be allowed to get away with.

In light of the forgoing paragraph, all those units which had been part of the 2025 Electoral College continue to be the only recognized units of RSFI and all other illegal affiliations so given by Mr. Bhagirth Dadhich are illegal. Only the recognized units alone are authorized to send their teams to participate in the 63rd National Championship, scheduled to be held in Karnataka, Kerala, and Tamil Nadu from December 5 to 15, 2025.

As I mentioned in my previous email and I reiterate now—I will not be writing on this matter repeatedly—all official correspondence must be issued exclusively through the official RSFI email ID, as had been decided collectively by us. Hence, correspondence originating from Bhagirath Kumar by using personal email id will not be recognized at all.In the circumstances, the federation will not provide Match Box / Gun Power to a person who is gone Bizarre and Berserk.

Therefore, any letters or correspondence / circulars issued by Mr. Bhagirath to anyone including state associations are hereby declared as void ab ini-tio. This apart I wish to state that such an atmosphere will not continue indefinitely and there has to be an end to it.

In view of these ongoing disruptive activities, appropriate and necessary action has to be taken against Mr. Bhagirath going forward. Apparently his behaviour and activities goes to so that as if 'a bull is in the china shop' which connotes that the bull is out to uproot and destroy mindlessly everything around.

Any contemplated action which is being thought of is to uphold the supreme interest and to protect the reputation of our sport, athletes, and the federation, which certainly is of paramount significance and importance for all of us.

You all are advised to go as per the yesterday's announcement of 63rd National Roller Skating Championship 2025 to be held at Karnataka, Kerala, and Tamil Nadu and make your preparations accordingly.
