Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ or Order or a direction, more particularly in the form of writ of mandamus, declaring the action of the 4TH respondent in postponing

the 63rd National Roller Skating Championship 025 unilaterally vide circular ref. no RSFI/PO/2025/10/9 dated 29.10.2025 as illegal, arbitrary and in violation of the bylaws of the 2NDrespondent society and consequently direct the 4TH respondent to conduct the 63rd National Roller Skating Championship - 2025 from 5TH to 15TH December 2025 at Visakhapatnam by strictly adhering to the minutes of special general meeting of the federation held on 24.05.2025.

IA NO: 1 OF 2025

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the 4TH respondent to conduct the 63rd National Roller Skating Championship 2025 from 5TH to 15TH December 2025 at Visakhapatnam by following the decision of the minutes of the special general meeting of the federation held on 24.05.2025, Pending disposal of WP 31670 of 2025, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri S Dushyanth Reddy, Advocate for the Petitioner and of Additional Solicitor General of India for the Respondent No.3, the Court made the following

ORDER:

"On 04.09.2025, this Court, in I.A. Nos. 1 and 2 of 2025 in W.P. No. 23631 of 2025, granted interim directions as prayed for.

On 24.05.2025, Respondent No. 2, during its General Body Meeting, resolved to host the 63rd National Roller-Skating Championship in Visakhapatnam from December 5 to December 15, 2025.

On 01.10.2025, the respondents decided to change the venue of the events to the States of Karnataka, Kerala, and Tamil Nadu.

The petitioner has challenged the unilateral change of venue in W.P.No.28612 of 2025. This Court, by order dated 16.10.2025, suspended the circular dated 01.10.2025 in I.A.No.1 of 2025.

Pending writ petitions, the 2nd respondent, through Ref. No. RSFI/PO/2025/10/9 dated 29.10.2025, has unilaterally decided to postpone the events.

Learned counsel for the petitioner submits that the petitioner has invested a substantial amount to organize the national events, and furthermore, the Visakhapatnam Metropolitan Region Development Authority (VMRDA) has sanctioned funds and is currently spending about one crore on repairs and renovation of infrastructure for the event. The counsel further submits that due to internal disputes between the 2nd and 4th respondents, a unilateral decision was taken by the 2nd respondent to postpone the event.

The event is scheduled to be held from 05.12.2025 to 15.12.2025. Therefore, due to dearth of time, this Court, after hearing the learned counsel for the petitioner and the respondents, in order to resolve the issue amicably, directs the 3rd respondent to conduct a meeting with the petitioner and respondents 1, 2, and 4 by issuing urgent notices to them and also to their counsel on record through e-mail/whatsapp, within five (5) days from today, and shall hear the matter independently and take an appropriate decision, in accordance with law, and submit the action taken report before the Court, by the next date of hearing.

Post the matter on 27.11.2025.

Till such time, the proceedings dated 29.10.2025 issued by the 2nd respondent shall stand suspended.

Office to communicate this order to the petitioner and respondent Nos.1 to 4 forthwith."
